

"Each day for the remainder of the first session of the 119th Congress shall not constitute a calendar day for purposes of section 202 of the National Emergencies Act with respect to a joint resolution terminating a national emergency declared by the President on February 1, 2025"



USMCA Review

Commence the public consultation process in preparation for the July 2026 review of USMCA

USTR assessment of the impact of USMCA on American workers, farmers, ranchers, service providers, and other businesses and make recommendations regarding U.S. participation in the agreement

Report to appropriate congressional committees on the operation of the agreement
