#### **Public Comment Period**

Chair Hayter solicited public comments. There were none.

#### Approval of Minutes for 09/13/23 Meeting

Chair Hayter asked for approval of the minutes from the September 13, 2023, Committee meeting. A motion was made by Mr. Rush and seconded by Mr. Harrell and the motion was unanimously approved.

Chair Hayter thanked VEDP staff for the tremendous work they are doing and gave his compliments on the information that was prepared for this set of meetings. He said he is pleased with the direction VEDP is heading.

# **President's Report**

Chair Hayter introduced Mr. El Koubi to deliver the President's Report.

Mr. El Koubi explained that he would provide a brief overview of his report and would deliver the full report during the Board meeting on December 7.

Mr. El Koubi stated that VEDP is substantially on track with its performance metrics and major initiatives for the fiscal year, but that he anticipates VEDP will face some headwinds in the future.

Mr. El Koubi shared that VEDP achieved an important milestone recently in filling open positions on VEDP's Executive Leadership Team. He spoke about the most recent addition to the team, Anita Begnaud as VEDP's new Vice President of Marketing & Communications. Mr. El Koubi mentioned that he and Ms. Begnaud worked together earlier in their careers in Louisiana. He highlighted some of Ms. Begnaud's experience, adding that she is extremely talented and one of the most collaborative people he has ever worked with. Chair Hayter said Louisiana's loss is Virginia's gain.

Chair Hayter said that the Board will look forward to Mr. El Koubi's full report during the Board meeting.
