






VEDP-Assisted Project Decisions N=13

NOTABLE DEVELOPMENTS SINCE OUR LAST BOARD MEETING

- Progress on state business climate rankings
 - Area Development: Virginia’s business climate ranking improved to no. 8 from no. 10
 - DCI (published once every three years): Virginia’s business climate ranking improved to no. 11 from no. 14, and VEDP’s state EDO ranking improved to no. 7 from no. 12
- Virginia Talent Accelerator Program engagement with several new projects, with rave reviews continuing (note: statewide expansion of program hinges on FY22 funding)
- Kickoff of International Trade’s new webinar series – “Accessing International Markets Virtually”
- Mailing of Q3 2020 issue of *Virginia Economic Review* (Aerospace, Aviation, and Unmanned Systems) earlier this month
- Extension of mandatory telework through end of December 2020 by Joint VEDP/VTC COVID-19 Response Team
- Outstanding value prop deliverables (e.g., industry brochure) for first industry sector (food and beverage processing)

TOP PRIORITIES THROUGH THE END OF 2020

- Engagement with the Administration and General Assembly to encourage focus on economic recovery in the upcoming Regular Legislative Session
- Pandemic relief and recovery planning in support of the Administration, with emphasis on four new/expanded growth opportunities
 - Reshoring of manufacturing and supply chains
 - Digital Virginia (e.g., data centers, software development, cloud computing)
 - Telework
 - Reskilling
- Completion of the strategic planning process, including a special focus on potential new opportunities and challenges in the post-COVID context
- Supporting the Virginia Early Childhood Foundation’s Back to Work Task Force
- Aggressive cultivation of several high-impact economic development projects
- Rollout of the Local and Regional Competitiveness Initiative (LRCI)
- Q4 2020 issue of *Virginia Economic Review* (Quality of Life in Virginia) development
- Continued focus on industry sector value proposition project
